Proposed Elimination of 21st Century Community Learning Centers
Puts Afterschool Programs at Risk



President Trump's full education budget proposal, released on Friday, May 30, contains deeply concerning news for Nebraska's children, families, and communities.

The proposal calls for the complete elimination of the 21st Century Community Learning Centers (21st CCLC) program - the only dedicated federal funding stream for afterschool and summer learning. This move is part of a broader \$12 billion cut to the U.S. Department of Education, dramatically reducing resources for programs that support youth development and family well-being.

The President's budget is the first step in the federal funding process; now, Congress must decide whether to accept or reject this proposal. That means the time to act is now.

What's at stake for Nebraska?

21st CCLC has a 20-year history of supporting locally driven afterschool programs that serve 1.4 million young people nationwide. In Nebraska alone, more than 17,000 youth in over 130 programs benefit from 21st CCLC grants, administered by the Nebraska Department of Education. With more Nebraska youth and families wanting access to these programs, and more interested communities than there is funding, Nebraska needs **more** 21st CCLC programs – NOT their elimination.

Under the President's proposal, 21st CCLC would be collapsed into a single \$2 billion block grant alongside 17 other programs - a pool of funding for all 18 programs that is nearly 70% smaller than what is currently allocated for these combined efforts. This would force 21st CCLC to compete for significantly fewer resources, effectively ending federal support for afterschool and summer learning programs.

Federal 21st CCLC funds are a critical part of Nebraska's afterschool ecosystem, heavily leveraged by local and philanthropic dollars to ensure safe, enriching spaces for kids during out-of-school hours. Losing these funds would mean fewer opportunities, greater risk, and more strain on working families across our state.

Congress has the final say in the federal budget, and our Nebraska representatives need to hear from you. Your voice can help protect the future of afterschool and summer learning in Nebraska. Use this link to **contact your members of Congress** and urge them to protect 21st CCLC funding.

The RFP will be released on June 20, with applications due by August 15. Funding will run from October 1, 2025, to August 31, 2026.

Freight Farm Internships

Over the last semester, we engaged high school and college student interns to work at our Freight Farm at The Career Academy at SCC Lincoln. The Freight Farm is a shipping container turned hydroponic farm that utilizes vertical grow walls, a high-output seedling station, and water-efficient tanks to sustainably grow large yields of greens for the community. We currently donate produce to the Food Bank of Lincoln and to SCC's and TCA's culinary arts programs.

Within the farm, interns had the opportunity to learn about and practice hydroponic growing and maintenance, while touching on topics related to plant science, chemistry, and local food systems. In addition to helping with hydroponic tasks, they also engaged in service-learning projects where they chose a need in their community, did research on their topic, and then planned an action project utilizing what they've learned at the farm, their research, and their strengths. We plan to utilize their projects for future programming and anticipate more internships to come!

The American Institutes for Research just released results from the *Power of Us Workforce Survey*! The Power of Us Workforce Survey is a national, cross-sector survey aimed at building a baseline understanding of the youth fields workforce—who they are, where they work, what they do, and what they experience on the job and in their careers. Adults in the youth fields work with children and youth in a range of sectors outside the school day, including out-of-school time, before- and afterschool care, summer learning, summer camps, sports, arts-based programming, experiential learning, mentoring, juvenile justice, housing and homelessness services, libraries, museums, and many more.
