Unit: Foundations of Government

Students consider how governments are established and maintained by exploring integral characteristics such as power, authority, legitimacy, and sovereignty. Students watch these characteristics at play as they learn about the development of democracy in ancient Athens and Rome, European monarchy, and early political philosophy.


