#### Michelle Arehart ELO Administrator Fellows

Beyond School Bells (BSB) is proud to announce the launch of the Michelle Arehart ELO Administrator Fellows. Named after Michelle Arehart, the long-serving director of the Kearney CLC program who was tragically killed in a car accident last fall, the year-long Michelle Arehart ELO Administrator Fellows will consist of between 6 to 8 experienced ELO program administrators selected from a statewide applicant pool to work as a cohort to learn about other Nebraska ELO programs, explore common challenges and propose solutions related to Nebraska's ELO programs. Importantly, in their applications, prospective Fellows will be asked to identify a challenge to ELO programs in our state that they would like to explore via their participation in the Fellowship program.

Elements of the Fellowship include:

- \$5,000 stipend per Fellow
- In person kick off meeting to design parameters, identify priorities
- Regular site visits at the Fellows home sites
- On-line, problem solving meetings between site visits
- Recognition at the 2025 GetConnected conference and
- Development and presentation of a final group product at state conference(s)

**BSB Funding Opportunity: Summer of Exploration** 



Just like afterschool learning, we believe summer programs are best with a student-centered approach. Following insight provided by Stephanie Malia Krauss in chapter 8 of *Whole Child, Whole Life*, BSB will offer summer program grants based on Student-Centered Learning and strategies to make the most of out of school time opportunities. BSB will support projects that:

- · Utilize Youth Voice and Choice
- Engage in Community-Connected, Age-Appropriate, Real-World Learning
- Foster Lifelong Learning and Pursuits.

Grants will be funded up to \$15,000 and will be limited to one per community. Eligible applicants will be school- or community-based Expanded Learning Opportunity programs serving school age youth. BSB will require all applicants to show youth voice and local support for their summer program and awarded projects must facilitate a youth brainstorming activity and develop a story-telling one pager (templates provided for each). ### **2025 Conservation Management Experiences**







To kick off conservation programming in 2025, BSB will be continuing our Conservation Management program including "Conservation Experiences" this April and May. 

Next Stop: Kearney Community Learning Centers (KCLC)!



Saddle up for an unforgettable ride! The Kearney Community Learning Center (KCLC) is all about innovation, community, and hands-on learning. This stop on our tour highlights KCLC's 5th-grade horseback riding program—where students do more than ride. They learn farm care, responsibility, and get up close with animals in a way they never have!

"Our students love this opportunity, as many of them have never been to a farm or ridden a horse." – Allison Morris, Park Elementary Site Coordinator



We asked Allison what she hoped for the future of afterschool. Here's what she said:

"The future of afterschool programming in Nebraska is bright! I hope we can continue to expand opportunities to reach as many students as possible, to be able to offer affordable educational programming.

Providing young students with a safe place to go afterschool is so crucial to their development. I would love to see communities come together and support their local afterschool programs and continue to help them grow."



Now in its 20th year, KCLC serves 10 schools and over 500 students daily!

"Our longest-serving site director has been with the program for 19 years, and most other site coordinators have served for 10 or more years.

We routinely have students who begin in our program in kindergarten, and stay with us all the way through 8th grade. We have past students who come back in high school and college to work for us!"
