New Threat to 21st Century Community Learning Centers Puts Afterschool Programs in Nebraska at Risk



On June 30th, the Office of Management and Budget (OMB) announced that pending a review of the program, funding for this year's 21st Century Community Learning Center (21st CCLC) program would not be provided to the states as agreed to in this year's budget that was signed into law by President Trump in March.

This unprecedented act by the OMB puts Nebraska afterschool and summer programs in a perilous position — without funding to pay salaries, they are unable to continue offering programming this summer and don't have the assurance they need to hire staff for the start of the 2025-26 year.

OMB's review, which is not subject to any timeline, combined with President Trump's full 2026 education budget proposal to eliminate all 21st CCLC funding, would be disastrous news for Nebraska's children, families, and communities and would have long-term, negative implications for our state.

What's at stake for Nebraska?

As reported in our last newsletter, 21st CCLC has a 20-year history of supporting locally driven afterschool programs that serve 1.4 million young people nationwide.

In Nebraska alone, more than 17,000 youth in over 130 programs benefit from 21st CCLC grants, administered by the Nebraska Department of Education. With more Nebraska youth and families wanting access to these programs, and more interested communities than there is funding, Nebraska needs **more** 21st CCLC programs – NOT their elimination.

Nebraska's 21st CCLC program has been thoroughly reviewed and was the subject of this **detailed report** on our website. This report captures the energy of the program and its findings mirrors what decades of research show – when Nebraska youth regularly participate in high-quality afterschool and summer programs like our 21st CCLC program, important things happen – their attendance in school improves, their behaviors get better, and, ultimately, their grades improve.

While it is not the only source of funding for afterschool and summer programs in Nebraska, the 21st CCLC funds are a critical, foundational element of Nebraska's afterschool ecosystem. Losing these funds would directly translate into fewer opportunities and greater risk for our children, more strain on working families across our state, and weaker, more vulnerable communities

What can we do?

The OMB's refusal to release these funds flies in the face of congressional direction and in the American system of government, Congress has the final say in establishing the federal budget. Our Nebraska representatives need to hear this refusal to honor budget commitments is not acceptable. Your voice can help protect the future of afterschool and summer learning in Nebraska. Conservation Management Internship 2025



During the first two weeks in June, BSB once again sent two groups of high school interns across the state on our Conservation Management Summer Internship Program to explore and participate in conservation work in Nebraska. This year's program took students, led by college mentors, to UNO's Glacier Creek Preserve, Nebraska Wildlife Rehab,



Fontenelle Forest, Ponca State Park, Prairie Plains Resource Institute, UNL's Cedar Point Biological Station, Meadowlark Hearth Organic Farm, Bayard Elementary School, NorthPlatte Natural Resource District, Ian Nicholson Audubon Center at Rowe Sanctuary, and the Crane Trust.



At each stop, the interns learned about site specific conservation issues, helped with or engaged in conservation activities, and networked with professionals. Students were able to see the diversity of Nebraska's landscape, participate in service-learning, and learn about ways they can get involved in conservation in their communities. They also learned about the diversity of conservation careers and how they can bring conservation back to their schools, homes, or communities. In addition, participating youth learned life skills including how to cook on a grill, how to skin and gut a fish, and how to teach youth and work with others.

A special thank you goes to the Nebraska Environmental Trust and the Claire M. Hubbard Foundation for once again supporting this great opportunity for Nebraska youth to learn about and instill a passion for conservation in our beautiful state. And a final thank you also to our great partners that allowed the interns to have amazing experiences as they learn about all the impactful work conservation professionals do every day in communities across Nebraska.
