YOUR PROGRAM'S FUNDING IS ON THE LINE!

The Trump administration's proposed budget would eliminate dedicated federal funding for afterschool and summer programs by cutting the 21st Century Community Learning Centers (21st CCLC) initiative. If approved by Congress, this proposal could end funding for your program and thousands of others like it nationwide.

But this isn't final—Congress has the power to stop these cuts.

Now is the time for you to speak up!

This mailing gives you step-by-step resources to take action:

- Give each of your sites the three following enclosed packets. Each includes:
 - A Site Packet for each site's staff and students to take action and speak up (sample letters, call-in scripts, a congressional map, etc.),
 - o A Family Packet for each site leader to give to afterschool program families, and
 - $\circ\,$ A District Leader Packet for the site leader to give to building and/or district administrators.
- Call, write, or email your U.S. Representative and U.S. Senators. Ask them to keep dedicated funding at the current level for 21st CCLC programs. Not sure what to say? Check out the sample script in the Site Packet or on the Afterschool Alliance website (afterschoolworksforamerica.org) or use the automated email option available through the QR code below. Note: As a private citizen you can lobby for 21st CCLC funding. It is ok to do this and we need you to do this. Make your phone call from your personal phone on your own time (lunch, after work), and use your personal email address or home address when writing.
- **3** Encourage your staff to call, write, or email too. Encourage them to share the impact losing their after school job will have on their families. (Again, on their own time from their personal phone or email.)

Now is the time to engage others!

- Ask your site leaders to engage youth in an activity where youth can tell elected officials about the afterschool program. Educating policymakers about the benefits of afterschool is NOT lobbying. As long as you don't mention the budget, the cards, letters, poems, and videos about your program are just a part of the normal educational outreach, which is allowed and encouraged of all 21st CCLC grantees! Consider these ideas:
 - Older students can write letters or poems sharing the positive impact the afterschool program has had on them and their families.
 - Younger students could draw pictures of what they like about afterschool.
 - Divide the items, and send them to the U.S. Representative for your program's community, along with both U.S. Senators.
